



School Music Program Enrollment Policy

The Reno Phil Youth Orchestras are intended to supplement public school music programs, not replace them. Members who attend a public school **with a large ensemble program** for their instrument are required to enroll in the school ensemble while they are in the Youth Orchestras. Exceptions will be made for:

- a) Homeschool/virtual school/charter school/private school/Davidson Academy students
- b) Large ensembles that rehearse on Monday nights

Students who meet the above criteria do not need to submit any paperwork. Students who do not meet these criteria but have other reasons not to enroll in an ensemble must submit a completed teacher statement from their primary ensemble teacher.

Alternate programs are acceptable, but only with the approval of the primary ensemble teacher. Acceptable programs for all participants are choir, band, orchestra, and jazz ensemble. A form is available for alternate ensemble participation and must be signed by both the primary and alternate ensemble teachers. Requests are subject to Reno Phil EdCE (Education and Community Engagement) committee approval.

Requests for exemptions must be submitted by Friday, May 7, 2021, and will be reviewed by no fewer than three members of the Reno Philharmonic EdCE Committee. Applicants will be informed of the committees' decision prior to auditions.

Scheduling and sports conflicts are not automatic grounds for an exception. It is expected that musicians playing at this level make choices about extracurricular activities that are fair to the rest of the ensemble. Full exemptions will only be granted in extreme circumstances on an individual basis. Any student found to not be enrolled in their school program without an approved exception is subject to immediate removal from the RPYO.

This policy supports the RPYO philosophy of complementing school music programs while considering the value of broad and deep musical learning experiences and the need for academic scheduling flexibility.

Online/virtual schools, home schools, and schools with no large ensemble suitable for the student's primary instrument are exempt from this requirement. Students in these exempted categories are encouraged to research enrollment in public school ensembles.
